Interest Rate and Interest Charges		September 1, 2023
Annual Percentage Rate (APR) for Purchases	<b>14.90% to 18.00%</b> introductory APR on purchases during the first six (6) months of account opening. Thereafter, your APR for purchases will be <b>16.90% to 18.00%</b> but will vary with the market based on the Prime Rate* and credit worthiness.	
APR for Balance Transfers	<b>15.90% to 18.00%</b> for six (6) months After that the APR will be <b>17.90% to 18.00%</b> . This APR will vary with the market based on the Prime Rate* and credit worthiness.	
APR for Cash Advances	<b>17.90% to 18.00%</b> . This APR will vary with the market based on the Prime Rate* and credit worthiness.	
Penalty APR and when it applies	<b>18.00%</b> APR. This APR may be applied to your account if your account is Past Due by Two Minimum Payments. <b>How long will the Penalty APR apply?</b> If your APRs are increased for this reason, the Penalty APR will apply until you make <b>six</b> consecutive minimum payments when due.	
Minimum Interest Charge	If you are charged interest, the charge will be no less than \$0.50.	
How to Avoid Paying Interest on Purchases	Your due date is at least 25 days after the close of each billing cycle. We will not charge you any interest on purchases if you pay your entire balance by the due date each month. We will begin charging interest on cash advances and balance transfers on the transaction date.
